Minutes of the Administration and Operations Committee Meeting held January 21, 2016

IT Projects Portfolio. As a matter of information, Committee members received the ERS IT Portfolio Report dated January 21, 2016. Ms. Reid handed out an updated page 13 for the Portfolio Report. Ms. Reid updated the Committee on the technology projects, applications stats, 2015 completed projects and activities, upcoming projects and a snapshot of the IT portfolio as of January 1, 2016. Discussion ensued.

Organizational/Personnel Update. As a matter of information, Committee members received a copy of the Organizational/Personnel Update. Mr. Allen provided an update on the ERS reclasses and reorganization in progress. Mr. Allen spoke about all the changes going on in ERS due to promotions within the office. Ms. Cleary indicated this is basically a housekeeping matter. It was moved by Mr. Matson, seconded by Mr. Pace, and unanimously carried, to approve the Experis Statement of Work #2.
