IT Projects Portfolio. As a matter of information, Committee members received the ERS IT Portfolio Report dated March 17, 2016. Ms. Reid updated the Committee on the current technology projects of the Filenet P8 Upgrade Implementation, Windows Server Upgrade, and various MERITS Optimization projects, including the Benefit Amount Adjustment and Payroll Processing. The IT General Controls and Software Licensing Audit have been completed and the ERS anticipates Experis to report on these audits at the April Administration & Operations meeting. All other IT projects/tasks are on schedule and proceeding with no issues. Committee members also received a snapshot of the portfolio as of March 10, 2016.

Organizational/Personnel Update. As a matter of information, Committee members received a copy of the Organizational/Personnel Update. The ERS Reclasses and Reorganizations are still in progress. The staff is working with the Department of Employee Relations to fill the Records Technician II and Pension Specialist Senior positions.

Baker Tilly Financial Audit. Mr. Baker and Ms. Middleman met with the committee for its annual meeting and progress update regarding the pending financial audit. No issues were discovered in the preliminary audit.

Mr. Patti indicated it was his intent to adjourn the meeting from closed session. It was moved by Mr. Matson, and seconded by Mr. Pace
