Upon motion of Mr. Hass, seconded by Mr. Kroenke, and unanimously carried, the communications were ordered placed on file.

The Secretary reported receiving a number of complaints, written on ballots, that the member did not know the candidates, and requesting that information be provided. It was suggested that the matter be reviewed for the next election.

Information Booklet

The Secretary reported that the Booklet of Information submitted by the Actuary was reviewed by Mr. Gumm and other Board members who suggested a redrafting of the information. Another draft will be submitted prior to the next meeting.

Bonding and Insurance Coverage

The Secretary reported that at the December 20, 1962, meeting of the Board (page 153), Mr. Strobel stated he would obtain a clarification regarding pension funds under the new city bond. Mr. Strobel stated that he does not have the information at this time.

Death Benefit Payment - William A. Hoyt

The Legal Adviser reported he talked to Attorney Zubrensky, who is handling the Hoyt case, regarding the death benefit payment, and that the attorney will contact the court regarding this matter.

Charter Ordinance No. 294

The Secretary reported that on February 1, 1963, the Common Council passed Charter Ordinance No. 294 to amend Section 36.05 (8) (b) 1, 2, 3, 4, and 6 of the Employes' Retirement Act increasing survivorship benefits for beneficiaries of firemen and policemen from \$75 per month to \$87.50 per month for payments to one survivor and from \$150 to \$175 per month for payments to 2 or more survivors. The ordinance was published February 13, 1963, and will become effective 60 days thereafter.
