## PROCEEDINGS OF ANNUITY AND PENSION BOARD

Minutes of the Regular Meeting held January 20, 1977.

The meeting was called to order at 2:02 P. M. by Chairman Robert W. Walker.

PRESENT: Messrs. Carl E. Hanneman, Kenneth H. Mandt, Clarence M. Miller, W. Martin Morics, Roy B. Nabors, Miss Ruth A. Poehlmann, Robert W. Walker, and Edmund M. Wisniewski; also Messrs. William J. Lukacevich and Thomas E. Hayes, Legal Advisers, Rudolph E. Pede, Secretary, and Robert G. Nehls, Assistant Secretary.

ALSO PRESENT: Messrs. Jack Windsor, Richard Farren, and Richard Stanley,
Heritage Investment Advisors, Inc., Investment Counselors;
Gene Gilbert, Bache & Company, Inc., and Joe Ellis, representing
Labor Negotiator.

Mr. Miller arrived. Mr. Nabors arrived.

## Appointment of Alderman Roy B. Nabors

The Secretary reported that the President of the Common Council, Alderman Ben E. Johnson, on December 22, 1976 appointed Alderman Roy B. Nabors to the Annuity and Pension Board to fill the unexpired term of Warren D. Braun through August 31, 1979, and that the appointment was confirmed by the Common Council on January 18, 1977. Board members welcomed Alderman Nabors and extended best wishes. Alderman Roy B. Nabors then took his oath of office as provided in Section 36.15 (4) of the Employes' Retirement Law.

#### Minutes

It was moved by Mr. Morics, seconded by Mr. Miller and unanimously carried, that the minutes of the regular meeting held December 16, 1976 be approved as submitted.

The Secretary reported that the June 17, 1976 minutes were inadvertently submitted to the Board without the following passed motion: "It was moved by Mr. Wisniewski, seconded by Miss Poehlmann and unanimously carried, that the minutes of the regular meeting held May 20, 1976 be approved as submitted." It was moved by Miss Poehlmann, seconded by Mr. Wisniewski and unanimously carried, that the minutes of the regular meeting held June 17, 1976 be approved as corrected.

#### Seminar Attendance

The Secretary reported on letters dated January 6, 1977 to the Board and December 16, 1976 to Alderman Kalwitz, Chairman of the Common Council Finance Committee, from Board Member Kenneth H. Mandt, copies sent to Board members with meeting notice, requesting that he be authorized to attend the International Foundation's Advanced Trustees Institute, June 12 thru 15, 1977 in Tahoe, Nevada via the Common Council Seminar Fund, which request Alderman Kalwitz advised Mr. Mandt must be made by the Board on his behalf.

Mr. Gene Gilbert arrived.

After discussion, it was moved by Mr. Mandt, seconded by Mr. Hanneman and unanimously carried, that three board members annually be requested to attend Seminars via the Common Council's Seminar Fund.

After further discussion, it was moved by Mr. Mandt, seconded by Mr. Wisniewski and unanimously carried, that a request be put before the Chairman of the Common Council's Finance Committee for Board Members Edmund M. Wisniewski and Kenneth H. Mandt to attend the New Trustees Institute in Quebec, Canada, June 26 thru June 29, 1977 and the Advanced Trustees Institute in Tahoe, Nevada June 12 thru June 15, 1977 respectively, with funds provided by the Common Council's Seminar Fund.

As a matter of information, the Secretary reported that the Municipal Finance Officers Association Convention attendance at Atlanta, Georgia April 17 thru April 21, 1977 has been approved for one Board Member and the Secretary by the Common Council on January 18, 1977. It was agreed that the convention requests authorized at the November 18, 1976 Board meeting be granted to three Board Members in the following priority:

- International Foundation's Educational Conference, San Francisco, California, August 5 - 10, 1977 Robert W. Walker
- International Foundation's Public Employes Conference,
   Tahoe, Nevada, October 2 5, 1977 Edmund M. Wisniewski.

Mr. Gene Gilbert left the meeting.

## Late Protective Survivorship Option Request

The Secretary, in response to the Board's request at the last meeting, reviewed in detail the past procedure relating to the handling of late Protective Survivorship Option requests including the Protective Survivorship Option details leading to Mr. Harry J. Daniels' November 10, 1976 written request for an extension of his deadline (8/23/74) to elect the Protective Survivorship Option.

The Investment Counselors arrived.
Mr. Gene Gilbert arrived.

After considerable discussion, it was moved by Mr. Hanneman and seconded by Mr. Mandt, that Mr. Daniels be allowed his request to make a late election under the previous conditions as we have done for other employees, provided he furnishes a medical affidavit, and that he be given 30 days from the date of his written notification in which to elect the option. The motion lost by the following vote:

NOES: Messrs. Miller, Morics, Nabors, Miss Poehlmann, Walker and Wisniewski.

## Additional Unfinished Business

Board Member Edmund M. Wisniewski inquired regarding the status of the Board's request for a legal opinion on Investment Counsel Selling Authority. The Secretary advised that we have nothing further on the matter since the last legal opinion of October 22, 1976, and that the subject will be up for discussion by the Investment Committee with the legal adviser present, hopefully, before the next Board meeting. Also, in response to Mr. Wisniewski's request the Secretary advised that in connection with the Cybela case the matter of a deceased Fire or Policeman's 'Duty Disability Member Contributions' is awaiting the receipt of a legal opinion from the Milwaukee Professional Fire Fighters' Association, as promised by Mr. Joseph Ruditys.

#### Bills

The Secretary presented a list of bills for December in the amount of \$64,359.45, copies sent with meeting notice to be attached to these minutes. It was moved by Mr. Mandt, seconded by Miss Poehlmann and unanimously carried, that the bills be approved and payments ratified.

Mr. Lukacevich left the meeting.

### Investment Transactions

As a matter of information, the Secretary presented list of Investment Transactions settled during the month of December 1976, copies sent with meeting notice to be attached to these minutes.

The Secretary then requested approval of the December 1, 1976 Sale of 500,000 Georgia Pacific Corp. 6-1/4% Convertible Sub. Debentures, Due 5/15/2000 as recommended by Investment Counsel on December 1, 1976. It was moved by Mr. Mandt, seconded by Mr. Hanneman and unanimously carried, to approve the sale of 500,000 Georgia Pacific Corp. Convertible Sub. Debentures.

#### Investments

Mr. Windsor reported on the name change of their company from Newton and Company to Heritage Investment Advisors, Inc.

Mr. Windsor presented the Investment Counsel agenda and lists of activity committed since the December 16, 1976 Board meeting (copy to be attached to these minutes).

Mr. Stanley reviewed the Short Term Investments and the activity in the fixed income portfolio and discussed that portion of the agenda.

Mr. Farren reviewed the activity in the equity portfolio and discussed that portion of the agenda.

Mr. Windsor reviewed the activity in the stock options program and discussed that portion of the agenda.

Mr. Gene Gilbert recommended that two million dollars more be allocated to the Pilot Option Program at this time.

After discussion Mr. Windsor requested that we lay this matter over until their Mr. Walter Beck has a chance to review this, after which they will make their recommendation. It was agreed that the matter be laid over to the February Board meeting.

Mr. Mandt left the meeting.

Mr. Windsor presented Heritage letter of January 20, 1977 confirming their December 16, 1976 recommendation that the net 1977 investable cash flow be invested 70% in fixed income securities and 30% in equities. It was agreed that this recommendation be reviewed at the Investment Counselor's 1976 informational meeting on February 15, 1977 when they present their 1976 Investment Portfolio Report.

The Investment Counselors left the meeting.

## Retirements, Death Claims, and Refunds

The Secretary presented lists of activity since the last Board meeting, copies of which were sent with meeting notice to be attached to these minutes:

It was moved by Miss Poehlmann, seconded by Mr. Wisniewski and unanimously carried, that the above indicated retirements, death claims, and refunds be approved.

## Medical Council Report

The Secretary presented application for Duty Disability Retirement from #C-8320 Eugene J. Dominiak, effective February 1, 1977, and submitted report of the Medical Council certifying that he is physically incapacitated for the performance of duty as the natural and proximate result of an injury occurring in the actual performance of duty, and that he should be retired. It was moved by Miss Poehlmann, seconded by Mr. Hanneman and unanimously carried, to accept the certification of the Medical Council and that Mr. Dominiak be retired on Duty Disability Retirement.

The Secretary also presented application for Ordinary Disability Retirement from #C-17760 Jerry D. Brown, Jr. effective December 22, 1976, and submitted report of the Medical Council certifying that he is incapacitated for the performance of duty, that such incapacity is likely to be permanent and that he be retired. It was moved by Mr. Morics, seconded by Mr. Miller and unanimously carried, to accept the certification of the Medical Council and that Mr. Brown be placed on Ordinary Disability Retirement.

The Secretary also presented reports of the Medical Council relative to re-examinations, certifying that #C-12958 Frank J. Czecholinski, #C-16942 Henry A. Deer, #F-12415 Donald A. Dettmann, #C-11954 Edward L. Janczak, #A-10523 Norbert N. Meyer, #A-17114 Paul M. Pinter, #C-10824 William H. Rounseville, and #C-14699 Roy J. Schmidt be continued on Ordinary Disability Retirement. It was moved by Miss Poehlmann, seconded by Mr. Wisniewski and unanimously carried, to accept the certifications of the Medical Council and that Messrs. Czecholinski, Deer, Dettmann, Janczak, Meyer, Pinter, Rounseville, and Schmidt be continued on Ordinary Disability Retirement.

# Report of Special Physician Panel - 90% Duty Disability

The Secretary presented a report of the Special Three-Physician Panel relative to the annual re-examination of #F-15801 Michael Skiba, Jr., a former Firefighter, certifying that he be continued on Duty Disability enlarged 90% allowance. It was moved by Mr. Wisniewski, seconded by Mr. Hanneman and unanimously carried, to accept the certification of the Special Three-Physician Panel and that Mr. Skiba be continued on Duty Disability enlarged 90% benefit.

## Election of Officers

The Secretary reported that the rules designate the January meeting of the Board as the Annual Meeting at which time the Chairman and Vice Chairman are to be elected for a term of one year.

It was moved by Miss Poehlmann, seconded by Mr. Morics and unanimously carried, that Mr. Walker be nominated as Chairman for the ensuing year. It was moved by Mr. Hanneman, seconded by Mr. Miller and unanimously carried, that nominations be closed. It was moved by Miss Poehlmann, seconded by Mr. Miller and unanimously carried, that the Secretary be instructed to cast a unanimous ballot for the election of Robert W. Walker as Chairman.

It was moved by Mr. Hanneman, seconded by Mr. Miller and unanimously carried, that Mr. Mandt be nominated as Vice Chairman for the ensuing year. It was moved by Mr. Miller, seconded by Mr. Hanneman and unanimously carried, that nominations be closed. It was moved by Mr. Miller, seconded by Mr. Hanneman and unanimously carried, that the Secretary be instructed to cast a unanimous ballot for the election of Kenneth H. Mandt as Vice Chairman.

### Authorization to Sign Vouchers

The Secretary presented the following resolution in accordance with Section 36.15 (11) of the Retirement Act:

It was moved by Miss Poehlmann, seconded by Mr. Wisniewski and unanimously carried, that the resolution be adopted.

## Appointment of Investment Committee

The Chairman appointed the following as members of the Investment Committee for the ensuing year:

Mr. James A. McCann, Chairman, Robert W. Walker and Kenneth H. Mandt, with any other member of the Board as alternate.

#### Administrative Offices Consolidation

The Secretary presented December 14, 1976 letter from Edwin C. Whitney, Secretary, Special Committee on Organization and Methods on the subject: Possible Merger (Consolidation) of Administrative Offices and Staffing of Three Separate Pension Systems Into One, copies of which were previously furnished to the board, wherein comments were requested of the board.

Assistant City Attorney Thomas Hayes arrived.

After discussion, it was moved by Mr. Hanneman and seconded by Miss Poehlmann, that we respond to Mr. Whitney's letter in the negative saying that our recommendation is not to merge the administrative offices and staffing of the three pension systems into one.

(The following motion to lay-over superseded the above motion.)

After further discussion regarding the effect on existing staff and space, infringement on the vested and contractual provisions relative to the administration of our system and the desire for more time and information on the matter, it was moved by Mr. Nabors, seconded by Mr. Morics and unanimously carried, that the matter be laid over and have Mr. Whitney provide a cost benefit analysis of the efficiencies of the consolidation of the three pension systems provided to the Board in advance of the next meeting, with Mr. Whitney's presence requested, so the Board may have an informed discussion on the matter.

#### State Retirement Research Committee

The Secretary presented January 12, 1977 letter from Blair Testin, Director of the State of Wisconsin Retirement Research Committee relative to their engaging the services of a consulting actuary to aid in the comparison and analysis of the Milwaukee Funds and the possibility of some additional actuarial cost to our fund because of this and wherein he requests a response as to our willingness to cooperate in such a comparative study. Copies of the letter were sent to Board members and attorneys with meeting notice. The Secretary also distributed letter of January 17, 1977 from our Actuary, Robert L. Barnes, wherein he advises that until he sees what the Research Committee wishes the Wyatt Company cannot state that there would be no additional fee involved.

After considerable discussion, it was moved by Mr. Morics, seconded by Mr. Miller and unanimously carried, to write the Committee stating that the Board approves the study in principle but to seek a commitment from the State to pay any additional actuarial cost.

Mr. Nabors left the meeting.

### Charter Ordinance No. 440

The Secretary presented January 16, 1977 letter from Board Member Carl E. Hanneman requesting legal opinion relative to Charter Ordinance No. 440, passed December 23, 1976 amending Section 36.05 (3) (c) to the effect that Policemen who are found to be eligible for a duty disability retirement allowance on or after November 1, 1976 shall continue to receive such allowance during their period of eligibility until they reach age 63, at which time it will convert to a service retirement allowance. Copies of the letter and Charter Ordinance No. 440 were previously submitted to the Board.

After considerable discussion, it was moved by Mr. Hanneman and seconded by Mr. Miller, that Charter Ordinance No. 440 be referred to the City Attorney's Office for a legal opinion as to its compatibility with other sections of Chapter 36 listed in a letter dated January 16, 1977 from Carl E. Hanneman and also request that our legal adviser include in his opinion a general set of guidelines for administration of this ordinance. The motion lost by the following vote:

AYES: Messrs. Hanneman, Miller, and Wisniewski.

NOES: Messrs. Morics, Miss Poehlmann, and Walker.

#### Charter Ordinance No. 439

The Secretary passed out copies of Charter Ordinance No. 439, passed December 23, 1976 which amends Section 36.13 (5) (g) of the Retirement Act relating to State Service Credit.
